

At this juncture, we find no word to defend our stand at circle level when the grass root members questioned yesterday expressing their loss of confidence in JAC which succeeded only to achieve a diluted solution put forth by the management on 12th May last.

JAC Assam Circle met yesterday at Guwahati to review the outcome of JAC at CHQ in the meeting held with CMD, BSNL on 20th June and to decide the course of action to be taken at Assam Circle level by JAC. JAC demands immediate settlement of following issues failing which there will be enmasse resignation from JAC Assam.

1. Immediate cancellation of inter circle transfer order of Com. Nazrul Islam, SDE, Bongaigaon.
2. Immediately extricate most corrupt GM/Bongaigaon.
3. Immediate transfer of CGMT, Assam for involvement of rampant corruption.
